Foreword :

The Unesco Chair « Safeguarding and Promotion of Cultural Food Heritages », hosted by the Université François-Rabelais de Tours since june 2011, intend to promote a better knowledge of food heritages and to support the identifications and inventories project of these heritages.

The aim of the UNITWIN/UNESCO Chair program is the sharing and the transfer of knowledge within perspective of the development of North/South relations. A UNESCO Chair is an international structure for scientific advancement, which involves training, research, and academic exchange activities. A Chair must generate the creation of regional hubs of excellence in addition to strengthening a dynamic of networks and partnerships

For almost ten years, François-Rabelais University has been committed to a process that aims to make food one of its hubs of excellence. In the frame of the Unesco Chair, and in partnership with an international network of universities and research organisations, it intends to boost the research in Food Studies area.

The objectives of the Unesco Chair :

- Promote and give a better knowledge of food heritages in order to contribute to their protection and promotion, according to the 2003 Unesco convention for protection of immaterial cultural heritages
- Bring into focus the importance of food cultures, at the time of issues like food security and self-sufficiency or economic, farming and touristy development
- Identify the food heritages and be part of the classification involving the owners of these heritages, either leading directly the inventory works or supporting the inventory programs led by other organizations, in order to make easier the promotion of familial and food-producing cultivations and help the introduction of agricultural policies and responsible tourism
- Introduce and/or develop, in the university and in the partner organizations, master's degree and doctorate courses on the theme of food heritages, scholarship and academic staff mobility programs, in order to introduce the issues of protection and promotion of cultural food heritages and to consider food from the angle of social studies
- Create an international network, bringing together all the regions of the world and working on the conception of research and academic training tools dedicated to food heritages

The activities since 2011 :

- 3. **Training**: The Unesco Chair relies on a European Master of Food History and Culture. Since 2011, 20 students have been graduated and 4 thesis have been defended.
